  - a. Tri-Global Report
    - Sask Lottery sales are significantly lower than budgeted for in the fiscal year that ended March 31, 2015. Sales projections for the remaining for year of the current lottery license are not expected to recover. Due to the reduction in sales and future projections, the SLTF has revised the amounts available to grant from lottery profits for the life of the 5 year agreement.
    - Regina Sport lost funding for the District Dream Broker position. We are actively seeking new partnerships to keep the position.
    - The District system is under the microscope to meet Sask Sport outcomes. The new measurement framework will help us show that we are an effective organization.

## b. Annual Report

- We ran 12 NCCP courses, training 111 coaches. A significant increase from the previous year of 26 coaches.
- \$17,734 in Aboriginal Community Sport Development Grant funds were given to 4 applicants, giving 389 children and youth access to new sport opportunities.
- 17 field trips were funded through the Youth Experience Program, giving more than 500 children and youth the opportunity to participate in experiences such as Dallas Valley Ranch and the Western Development Museum.
- The Regina District Dream Broker Program enrolled 534 children and youth into the Dream Broker Program and helped connect them to 191 different sport, culture and recreation opportunities in Regina.
- The Board of Directors took part in some Policy and Governance training this year.
- RSD entered a new partnership with the school boards in Regina and distributed 2 publications that featured sport opportunities in Regina. More than 50 organizations participated, going out to more than 16, 000 homes.
- RSD gained 42 new members this year and have begun rebuilding those relationships in consultations.
